## 2017 STALLION SERVICE CONTRACT

#### **General Conditions**

- 1. Mare Care will be charged at the following rates: Dry mare: \$4.50 day; mare with foal at side: \$6.00/day.
- 2. Mare shall be in healthy and sound breeding condition. If mare is not maiden, the mare should be cultured prior to breeding. In case of any other illness or injury, the Mare Owner agrees that a suitable course of treatment may be undertaken by Farm's Veterinarian, at the Mare Owner's expense.
- 3. Diligent effort will be made to settle the mare. However, if for any reason she does not settle, Deep Creek Farm will not be held liable.
- 4. Deep Creek Farm guarantees a live foal, defined as one that stands and nurses. If a live foal does not result from this mating, as evidenced by a veterinary certificate within one week of foaling, the Mare Owner is entitled to one return privilege for the said mare. Return is not offered if mare is sold.
- 5. In the event that the above named stallion becomes unfit for service, this contract shall become null and void and the deposit will be refunded.

#### **Live Cover**

- 6. A current coggins certificate is to accompany the mare shipped to Deep Creek Farm for breeding.
- 7. Deep Creek Farm shall not be responsible or liable for any accident, illness or injury to the said mare or her foal, and the Mare Owner shall not be responsible or liable for any accident, illness or injury to the said stallion. Insuring the mare is the Mare Owner's responsibility.

- 8. It is recommended that the mare stay at Deep Creek Farm until she is confirmed pregnant. It is our policy to have mares ultra-sounded 14 18 days after the last breeding date to determine if they are pregnant and not carrying twins.
- 9. Stud fee will be due and payable once mare is confirmed to be pregnant. Service Fee, board for mare and any other outstanding fees must be paid when the mare is picked up. The mare will remain on the premises until all accounts are settled.

### **Artificial Insemination (AI)**

- 10. If the mare is bred by AI, the collection fees and shipping fees will be the mare owner's responsibility.
- 11. Collection & shipment will be done by White Oak Veterinary Service. Currently, the collection and testing fee is \$175. Shipping via Federal Express is approximately \$75 \$150. If applicable, the shipping container charge is \$275 unless container is returned within 10 days. These fees are subjected to change.
- 12. Stud fee will be due and payable once mare is confirmed to be pregnant.
- 13. LFF Ulend is not available for Al.

When this contract is signed by both parties, it will then be a binding contract on both parties, subject to the above terms and conditions.
